**Travel Fee:** \$100 per hour ( minimum \$100) The travel fee is due when signing this contract. Hotel, valet and other fees may apply.

### Pricing:

Formal styles \$120 each ( Gratuity is included )

Trial (1hour) \$100

Extensions ( consultation required)

We do not have a make-up artist at our salon but we have recommendations upon request.

**Contracted Services:** On the day of your wedding, you may add people receiving services if time allows. Once the contract is signed you may not take anyway any services. If someone wishes to not receive the service that was originally scheduled, regardless of the reason the person signing the contract assumes responsibility for payment.

**Covid Cancellation Policy:** If your stylist tests positive for Covid you will be refunded in full. If the state requires your venue to postpone or cancel events due to Covid you will be refunded in full. If your wedding is rescheduled due to Covid the deposit will be transferred to a future date if your stylist is available. If your rescheduled date is not available your deposit will be forfeited.
